## VALUE COVERAGE

Eagle Van Lines, Inc. is in compliance with federal transportation law that allows you, our customer, to insure your furniture and household goods during a move. You may also check with your homeowner's policy for possible moving coverage. Please check the **TERMS AND CONDITIONS** section.

### A. BASIC PLAN

Eagle Van Lines offers this plan to you **without charge**. The liability is 60 cents per pound, per item damaged or lost, (for local moves liability is 30 cents per pound, per item) and there is no deductible for this protection. To receive this plan, simply write on the bill of lading "60 cents per pound, per article."

### B. PREMIUM PLAN

This coverage will automatically be charged if you do not elect either of the options. Eagle will determine the value of your shipment by multiplying the actual weight of your shipment by \$1.25. The cost of this protection is 70 cents per \$100 of declared value. For example, a shipment weighing 8,000 pounds will have a declared value of \$10,000 and will cost you \$70. Eagle's liability for loss or damage is subject to maximum of the declared value. Coverage for damage or loss under this plan is based on a depreciated value of the item in question, according to the government's published depreciation schedule (available from Eagle's Customer Service Department). There is a **\$250 deductible** on all claims. Under this plan, items packed by you are not covered if the box they are delivered in is undamaged. In addition, Eagle's maximum liability for loss or damage on any item packed by you will not exceed \$750. Here is how this plan is calculated.

### C. EAGLE'S BEST PLAN

You may declare a value for your shipment and request "REPLACEMENT VALUE" protection. Eagle will value your shipment at a minimum of \$4.00 per pound, costing you 85 cents per \$100 of valuation. On items packed by Eagle Van Lines there is no deductible\*; on items packed by the shipper the deductible is \$250. If you desire zero-deductible coverage on any items packed by you, Eagle Van Lines **MUST** inspect the items before they are picked up. Eagle's liability for loss or damage is subject to the maximum of the declared value of the shipment, and condition at time of acceptance. **D. INTERNATIONAL/OVERSEAS SHIPPING INSURANCE**

You may declare a value for your overseas shipment and request "REPLACEMENT VALUE" protection. The coverage is available at 2.5% of the value of the goods. Please see attached information from Executive Insurance Services. Liability for loss or damage is subject to the maximum of the declared value of the shipment, and condition at time of acceptance. Here is how the plan is calculated.

**TERMS AND CONDITIONS**

**Please let us know in advance if you have items of exceptionally high value, so that we may make arrangements. If available, please present appraisals of your valuables at the time of your pick up and list each item on the driver's high value declaration form.**

- When shipping autos the customer's insurance company has the primary coverage for any damage claims. All claims made to EAGLE are subject to a \$250.00 deductible. Carrier's maximum liability shall be (1) the value stated in the current issue of the National Automobile Dealer's Association Official Used Car Guide or (2) the appraised value, whichever is less. For more information please see our AUTO TRANSPORT information sheet.
- Carrier may satisfy claims by repairing or replacing the property lost or damaged with materials of like kind, quality, and condition at time of acceptance by carrier. All items, which are replaced or for which full current market value have been paid, become the property of the carrier.
- Carrier's maximum liability shall not exceed the released or declared value on the shipment or the full cost of repair to the damaged property, whichever is less. Carrier shall have the option of repair or replacement of damaged articles.
- Carrier reserves the right to inspect all claimed articles and offer no compensation for items which were not presented during the inspection. All claims should be submitted in *writing* to the carrier's office.
